



## 2017 KRIMES AGAINST KIDS CONFERENCE FACT SHEET

The Florida Network of Children's Advocacy Centers' annual Crimes Against Kids Conference unites law enforcement officers, therapists, attorneys, social workers, and other professionals in the campaign to end child abuse. Attendees participate in indispensable training and networking opportunities, strengthening the multidisciplinary response to child welfare concerns on individual, institutional and community levels. Our Conference has earned an excellent reputation as evidenced by significant growth from 200 attendees in 2013 to over 300 attendees in 2014, 2015 and 2016.

### **General Information**

**Who:** Attendees include Children's Advocacy Center staff and community partners, such as law enforcement officers, therapists, social workers, attorneys, social services, CPT staff, medical professionals, and child advocates. Educators and community members are also encouraged to attend.

**What:** The annual Crimes Against Kids Conference provides three days of quality training on child maltreatment issues, at minimal cost. Seminars equip professionals with both practical and innovative solutions against the various forms of crimes against children.
